The prices of these products are fixed on yearly basis by a High Powered Committee, headed by the Principal Secretary, Finance Department, after which orders for supply can be placed on the J&K State Handloom Development Corporation Limited by the indenting Govt. Departments without inviting tenders or quotations. No decision is required to be taken by the purchase committees on prices and departments have only to ensure that they receive the goods as per the prescribed

It has been brought to the notice of the Finance Department that, occasionally, some Departments are violating the Govt. orders by purchasing textile items from suppliers other than the J&K HDC. Such violations have been viewed seriously by the State Govt and, apart from acting against the Govt. policy of promoting handloom products within the state through the efforts of J&K SHDC, this amounts to indiscipline. All Govt departments are impressed upon to make purchase of their textile requirements from the State Handloom Dev. Corporation only on the prices/rates fixed by the High Powered Committee in its meeting, held on 11.7.2012, under the chairmanship of the Principal Secretary to Government, Finance Department, and ensure compliance of the aforementioned Govi. orders.

The Financial Advisers/Chief Accounts Officers and Accounts Officers, posted in various departments, shall personally ensure compliance of these instructions and the concerned Treasury Officers shall not pass the bills for payments, presented to them, on account of such purchases made from sources other than the JKSHDC
