## **EXPRESSION OF INTEREST**

J&K Handloom Development Corporation Limited (JKHDC) invites Expression of Interest in pursuance of Revised Marketing Policy approved by the Board of Directors and in terms of Circular Instructions of Finance Department issued vide No.o1 of 2015 dated 23.06.2015 from eligible SSI Units/Societies/Handloom Clusters / Weavers/ Artisans belonging to the Union Territory of J&K and registered in textiles items for fixation of rates for various items mentioned in the Annexure-1 and as per the details/specifications mentioned in the tender documents for the financial year 2021-22

The interested tenderer should essentially be registered with JKHDC under Revised Marketing Policy of the Corporation approved by the Board of Director. The SSI units/Handloom Societies/Handloom Clusters / Weavers/Artisans who have not registered their units yet, shall invariably get themselves registered with JKHDC by or before **5<sup>th</sup> January 2021** in order to become eligible for participation in the tender process and only such registered SSI units/Societies/Weavers/Artisans shall be considered for placement of supply orders during the **F.Y .2021-22**. The tenders dully affixed with a revenue stamp of Rs.5/- should reach to the office General Manager (F), JKHDC, 5<sup>th</sup> Floor, Udyog Bhawan , Jammu/3<sup>rd</sup> Floor Sanat Ghar , Bemina , Srinagar by or before **18-01-2021 upto 3.00 PM**.

The tender must be accompanied with earnest money amounting to **Rs. 5000/-** for SSI Units/Societies and **Rs 500/-** in case of Weavers/Artisans in the shape of Cash Receipt of JKHDC or CDR/FDR duly pledged to J&K Handloom

Development Corporation Ltd failing which the tender shall not be entertained. However, tenders whose previous valid EMDs are lying with JKHDC need not to enclose the fresh EMDs for which they require to provide documentary evidence.

The tenders shall be opened on **23-01-2021 at 01:00 hrs**, in case of reasons beyond the control of management or any other unfavourable circumstances the tenders will be opened on subsequent day in presence of tenderers or their authorized representative who may wish to be present at the time of tender opening process at Head Office, Jammu.
