**Terms and conditions in reference to HDC/MD/Tender/Sales/766/2023-24/544 Dated: 28-08- 23**

1. That the party shall submit his offer letter along with Experience Certificate for minimum of 3 years in marketing the handloom goods through retail sale or Govt. agencies.
2. That the party shall submit the Registration Certificate for marketing of Handloom products.
3. That the party shall submit the audited balance sheets for the last 3 years.
4. That on the basis of documents, a preliminary inspection shall be made by JKHDC Committee to verify that the party has sufficient infrastructure and capacity to supply the handloom goods.
5. That a Bank guarantee of Rs. 5 lakh pledged to JKHDC shall be provided by the approved party for a period of one year which can be extended or released subject to business terms.
6. That the Corporation shall provide the sales material to the party after verifying the requisition in consideration of genuine handloom products and the value of bank guarantee. The Marketing Agency shall be solely responsible for damages caused to the stocks issued by the Corporation.
7. That the party shall clear the payment of supplies from time to time before raising of next purchase indent.
8. That the party shall not claim for return of stock, however replacement within 20 days shall be allowed after found genuine by the JKHDC Committee.
9. That the party/parties shall supply the material up to the designation of intending department and bear all type of expenses i.e transit insurance, carriage, taxes etc. up to destination.
10. That in case of any loss due to Strike, Riots, natural Calamities or civil Commotion shall be borne by the party.
11. That the party shall supply the goods as per the required specifications and according to the terms & conditions defined by the intending department. The rejection of material or penalty imposed by the department shall be at the cost of party and Corporation will have right to cancel the order and even discontinue the arrangement made with the party and deduct the loss from his Bank Guarantee.

12. That in case of any dispute, Hon'ble High Court of J&K will be the jurisdiction with J&K UT.


That before start of business, an agreement shall be made with the party to abide the above terms & conditions. That in case of any dispute, the decision of Managing Director JKHHC shall be final.
